Registration of new drugs manufactured in and imported to Sri Lanka needs to be registered with the National Medicines Regulatory Authority (NMRA) of the country for manufacturing, importation, distribution, storage, advertising and sale in the country.

# About Sri Lanka Pharmaceutical Industry

The pharmaceutical and medical equipment sector in Sri Lanka is heavily dependent on imports with around 85 percent of the requirement coming from abroad.

Sri Lanka's pharmaceutical market is expected to reach a value of USD750 million by 2025, with a five-year compound annual growth rate (CAGR) of 4.1%. Pharmaceutical sector is identified as one of the potential industries to attract Foreign Direct Investment largely.

The government plans to establish a pharmaceutical zone to manufacture some products locally. The Cosmetic Drugs and Devices Regulatory Authority regulates the pharmaceutical and medical devices sector to ensure the quality, safety, and efficacy of drugs and medical equipment.

Increasing access to private health services is also a focus of the government, as it is difficult for the public sector alone to meet the demand for healthcare services. The private sector has invested considerably in healthcare, especially in Colombo and some of the major cities, which has eased some of the burdens for the state. The demand for private sector healthcare has increased with higher income levels and changing preferences. The provision of health insurance has also supported the growth in the private healthcare sector. There are around 603 government hospitals, nearly 200 private hospitals of varying sizes, 5,000 private pharmacies, and 1,000 laboratories in Sri Lanka.

It is projected that by 2024, the market volume for Oncology Drugs will reach USS 38.67m.

Market volume is projected to reach USS 290.30m by 2029. Sri Lanka's pharmaceutical market is experiencing a surge in demand for herbal and traditional medicine products.





Among the various markets within this market, Cardiology Devices is projected to hold the largest share with a market volume of USS 32.95m in the same year.

This growth trajectory is predicted to result in a market volume of USS 223.80m by 2029.



# National Medicines Regulatory Authority (NMRA), Sri Lanka


National Medicines Regulatory Authority (NMRA) is the Drug Regulatory Authority under Health Ministry in Sri Lanka. NMRA mainly regulates and evaluates the medicinal products/drugs, devices, cosmetics, and manufacturing facilities with or without site visits.

NMRA issues wholesale licenses, retail licenses, and transport licenses for medicinal products/drugs and devices. NMRA along with Consumer Affairs controls the pricing for selected drugs and devices in Sri Lanka. Under NMRA there is a sub-department to approve labeling and advertising.

The Medicines Evaluation Committee (MEC), formed under the NMRA Act, carries out scientific and technical reviews, inspections and surveillance activities of the medicines forwarded for registration, to ensure quality, efficacy, safety, and cost of such medicines, as per the registration and certification procedures.


